# MINUTES CITY OF JOHNSON CITY

## CITY COUNCIL SPECIAL CALLED MEETING & BUDGET WORKSHOP

#### 1. CALL TO ORDER

The City Council Members of the City of Johnson City, Texas held a Special Called Meeting/ Budget Workshop Meeting on Wednesday, September 20, 2017 in the City Council Chambers located at City Hall, 303 E Pecan Drive, Johnson City Texas.

City Council members present were: Mayor Dawn Capra, Mayor Pro-Tem Rhonda Stell, Gayla Jo Guthrie, Pat Dildine, Rosie Danz, and Shelton K. Coleman. A quorum was present.

Bill Weaver provided informational packet to the City Council regarding the Hill Country Area Crime Stoppers program. Additionally, they provided David Conlan an award for this gracious donation to the Hill Country Crime Stoppers organization.

a) RECEIVE CITIZEN COMMENTS REGARDING THE PROPOSED 2017-18 MUNICIPAL BUDGET WHICH INCLUDES: GENERAL, SYSTEM, AND HOTEL/MOTEL FUNDS.

b) RECEIVE CITIZEN COMMENTS REGARDING THE PROPOSED 2017 AD VALOREM TAX RATE AND LEVY OF \$0.465 OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE CITY LIMITS OF THE CITY OF JOHNSON CITY.

The City Council convened into the Public Hearing at 6:21 p.m. with no comments from citizens and closed the public hearing at 6:25 p.m.

6. DISCUSSION AND ACTION TO APPROVE ORDINANCE #17-0901 WHICH ENACTS THE MUNICIPAL BUDGET FOR THE 2017-18 FISCAL YEAR FOR THE CITY OF JOHNSON CITY.

Council Member Dildine made a motion to approve Ordinance # 17-0901 enacting the 2017-18 Municipal Budget. Council Member Danz seconded the motion and the motion was carried with Council Members: Dildine, Stell, Danz, Guthrie, and Coleman casting a yea vote; and none casting a nay vote.

7. DISCUSSION AND ACTION TO APPROVE ORDINANCE #17-0902 APPROVING THE 2017 AD VALOREM TAX RATE AND LEVY OF \$0.465 CENTS PER ONE HUNDRED DOLLARS (\$100) OF ASSESSED VALUATION OF ALL TAXABLE PROPERTY WITHIN THE CORPORATE CITY LIMITS OF THE CITY OF JOHNSON CITY.

Mayor Pro-Tem Stell made a motion to approve the 2017 ad valorem tax rate and levy of \$0.465 for every one hundred dollars of assessed valuation of all taxable property. Council Member Dildine seconded the motion and the motion passed unanimously with Council Members: Dildine, Stell, Danz, Guthrie, and Coleman casting a yea vote; and none casting a nay vote.
